## SHOP LOUISIANA TAX FREE!

Louisiana provides a sales tax refund for international shoppers. The refund is instantly available at convenient locations throughout the state, or a visitor can choose to receive a check by mail.

Tax-free shopping is available on purchases made at nearly 900 participating stores.

Not to be confused with "Duty Free" shops in airports, the Louisiana Tax Free Shopping Program for International Visitors (LTFS) is available at a large variety of well-known stores. LTFS partners include manufacturer outlets, department stores, jewelers, art dealers and antique shops in addition to hundreds of specialty shops throughout the state. Major shopping centers in New Orleans and Baton Rouge are tax-free zones.

There is no refund available for personal services such as hotel rooms, restaurants, entertainment and transportation.

### HERE'S HOW IT WORKS:

- Present passport or picture ID at time of purchase
- Receive LTFS voucher
- Redeem voucher at LTFS Refund Center or submit later by mail

## EASY AS 1-2-3

1. Bring your foreign identification shopping with you, and shop at over 800 participating stores
2. Show the cashier your identification and receive a Tax Free "voucher" attached to your receipt(s)
3. Bring your vouchers, receipts, passport and international airline ticket to one of our five redemption centers located throughout the state of Louisiana and receive your refund in CASH!

### ESPAÑOL

1. Cuando vaya de compras, lleve su identificación nacional y preséntela en más de 800 tiendas participantes.
2. Presente su identificación a la cajera y reciba un 'comprobante' Tax Free con su recibo.
3. Traiga sus comprobantes, recibos, pasaporte y billete de vuelo internacional a uno de nuestros centros de reembolso, ubicados por todo el estado de Louisiana, y reciba su reembolso en EFECTIVO!

### FRANÇAIS

1. Munissez-vous d'une pièce d'identité quand vous faites votre shopping. Plus de 800 magasins participent au programme.
2. Montrez au caissier votre pièce d'identité et recevez un bordereau de détaxe avec votre ticket de caisse.
3. Apportez vos bordereaux, vos tickets de caisse, votre passeport et votre billet d'avion international à l'un des cinq centres de détaxes situés en Louisiane et recevez votre remboursement EN ESPÈCES !

### PORTUGUES

1. Traga a sua identificação do seu país quando for às compras e visite mais de 800 lojas que participam neste programa.
2. Mostre a sua identificação ao caixa da loja e receba um voucher de Tax Free juntamente com o(s) seu(s) recibo(s).
3. Traga os seus vouchers, recibos, passaporte e passagem de avião a um dos cinco centros localizados no estado de Louisiana para receber de volta a quantia gasta em impostos em dinheiro.

### DEUTSCH

1. Bringen Sie zum Einkaufsbummel Ihren Reisepass mit und gehen Sie bei über 800 teilnehmenden Läden einkaufen.
2. Wenn Sie Ihren Reisepassen an der Kasse vorlegen, erhalten Sie zusammen mit dem Kassenbeleg einen „Steuerbefreiungsgutschein.“
3. Bringen Sie Ihre Gutscheine, Kassenbelege, Ihren Reisepass und Ihr internationales Flugticket zu einem unserer fünf in Louisiana ansässigen Erstattungszentren und Sie erhalten Ihren Erstattungsbetrag in BAR!
